The below information supplied by Gerald David "Gerry" Willburn a decendent of William Richard Welborn's brother Edward Welborn. (Both sons of Edward Wilbourn abt 1725-1806).

"THE WILL OF EDWARD WILBOURN - 1806 SURRY COUNTY, N.C.

In the name of God Amen. Considering the uncertainty of this mortal life and being of sound mind and memory, blessed be the Almighty God for the same, do make and publish this my last will and testament in the manner and form following, that is to say;

First, I give and bequeath unto my beloved wife Mary Wilbourn, all the tract and parcel of land I now live on, that is on the Northeast side of Mitchell's river, three hundred and fifty acres, to my wife as long as she lives, also one man, twenty two head of cattle, six sheep, forty head of hogs, three feather beds, with all their furniture, three bed stedds, two dishes, twelve plates, six knoves and six forks, sixteen spoons, one large cason and two small ones, six chairs, likewise all my farming tools. Also I give and bequeath to my wife Mary Wilbourn, my negro fellow Jeffrey, as long as she lives.

I do also give and devise all my tract of land lying on the Southwest side of Mitchel's river to my son Richard Wilbourn.

I do also give and bequeath unto my son Edward Wilbourn the sum of two hundred dollars at my wife's decease.

I do also give and bequeath to my daughter Jane Wilbourn one half of the land I live on and of the Northeast side of Mitchel's river at my wife's decease.

I do also give and bequeath unto to my daughter Temperance Marshall the remaining half of the land on the Northeast side of said river at my wife's decease.

I do also give and bequeath unto my two daughters Jane Wilbourn and Temperance Marshall all my stock of every kind and all my household furniture of every kind, and my negro fellow Jeffrey, at my wife's decease, to be equally devided between the two daughters if they can agree in the property, if they can not agree in the division of the property, the property is to be sold and the money arriving from the sale to be equally divided between Jane and Temperance.

I hereby appoint my wife Executrix and Aaron Marshall Executor of this my last will and testament hereby reversing all wills by me.

ADDITION

I, Edward Wilbourn, of the State and County aforesaid do this 5th day of May 1806, do make and publish this my codicil to my last will and testament in manner following, that is to say;

I give to my son John Wilbourn five shillings. I give to my son Thomas Wilbourn five shillings.

I give to my son Zachariah Wilbourn five shillings.

I give to my son Lewis Wilbourn five shillings.

I give to my daughter Susanna Jones five shillings.

I give to my daughter Lydia Slauter five shillings.

State of North Carolina, Surry County, May session AD 1806Obadiah Martin and Aaron Marshall, two of the substantiating witnesses, (to the foregoing last will and testament, together with the Codicil of Edward Wilbourn) made oath that they saw the said Wilbourn sign, publish and declare the same to his last will and testament, that he was of disposing mind and at the same time they saw Jennet Wilbourn sign the same as a witness to said will and codicil which was ordered to be recorded."

Jennet (Jane) Wilbourn was Edward Wilbourn's youngest daughter. She never married.

Mary (St. Clair) Wilbourn was in the 1810 Surry Co. Census as Molly Wilbourn with her daughter, Jane and 1 slave, Jeffrey. The tax lists show her as owner of the land until 1819. She appears in the 1820 Surry Co Census living next to her son Richard. She must have died not too long after that. I don't know the exact
